Editorial introductions.

He does much to clarify the intricate course of some 150 years during which the slow disintegration of the Ottoman Empire became a basic issue in European affairs and world politics. - Atiya, Aziz S. Crusade, Commerce and Culture. Bloomington: Indiana University, 1963. 280 pp. \$6.00. A unique new history which views the Crusades as part of a perennial East-West movement, based on both Western and non-Western sources.

By a well-known American historian, it centers on the rise and spread of Islam, the Ottoman Empire, European imperialism, and the contemporary Middle East. Excellent bibliographies.






